Low mountainous area with diverse relief. It contains mostly broadleaved forests of Cephalanthero-Fagion, and mixed oak forests.

Natural broad-leaved xeromesophilous and xerotherme forests. The single location of the Balkan endemic *Aesculus hippocastanum* forest for the country. Seminatural xeromesophilous grasslands are fragmentarily presented.
