Other Site Characteristics

"Mominbrodsko blato" is an old channel of Lom river, which is separated in two parts (bigger and smaller) by an embankment and a road. It is semi-natural eutrophic lake with Magnopotamion and Hydrocharition - type vegetation. The water surface is 26.6 ha. The lakeside is reedy with Phragmites australis and Thypha angustifolia. There is a lot of fish.

4.2 Quality and importance

The site is a semi-natural lake near Danube. It is rare habitat for the preservation of water flora and fauna (birds, fishes etc.). The site must be established as protected area as well.
