Other Site Characteristics

The site includes the Chirpan Heights in the Gornotrakiyska Valley, which are connected to Sarnena Sredna Gora mountain and are located north of the town of Chirpan. They are characterized by hilly terrain, indented by dry valleys and valleys of small rivers. The ridge of the hills reaches about 600-650 m. The northern slopes of Chirpan Heights are steeper. To the south the hills gradually descend to the valley through which Maritsa river flows. Their highest peak is Kitka - 652 m.

4.2 Quality and importance

The site protects one of the most compact and representative localities of habitat type 91AA south of the Balkan Mountain and is essential for the conservation of this habitat type in Bulgaria. Its representativeness involves the typical species composition, forests age, degree of preservation of function and structure of fthe orest communities. The forests are of low economic use.
